Chair's Corner

Show Me the \$cience



The science behind clinical dentistry continues to grow and advance. As clinicians we are bombarded with information from myriad sources including email, electronic media, journals and online publications. Evidence based health care is not a new concept having been around for over 20 years. The goal is to integrate the best available scientific evidence into clinical practice so that optimal patient outcomes are achieved. If you

haven't seen it there is even a journal titled "Evidence Based Dentistry" (EBD) that emanates from the Centre for Evidence Based Dentistry in Oxford England. The American Dental Association has had a Center for Evidence Based Dentistry for 6 years. The Center has provided a variety of systematic reviews of the evidence on a diverse range of topics from fluorides and sealants to mid-level providers. These scientific reviews follow a structured and stepwise approach to address a clinical question and the process typically results in the generation of clinical recommendations and/or guidelines. Clinicians are then able to take this information and incorporate it as a part of their decision making process when selecting therapeutic approaches for their patients.

The American Academy of Pediatric Dentistry (AAPD) has a goal to be the world's leading resource for credible information regarding the oral health of children. To help meet this goal the Academy has established an Evidence Based Dentistry Committee that will work with existing AAPD Councils, workgroups, the ADA and other

groups. This new committee will apply this structured evidence based process to help further develop and refine the extensive and invaluable guidelines and clinical care recommendations that are published in our AAPD Guidelines. I am serving on the committee and Jessica Lee is the liaison to the committee from the Board so North Carolina is well-represented.

Having now been involved with numerous EBD reviews it is fascinating to see what conclusions the science supports. For example in the ADA review on non-fluoride caries agents (JADA 2010) it was found that 0.12% chlorhexidine rinse is not an effective therapeutic for controlling dental caries. This approach has been and continues to be recommended by some groups despite the evidence that it is ineffective. Chlorhexidine rinse (0.12%) is a prescription item, not inexpensive and given the evidence that it is ineffective should not be used for caries control. Not surprisingly the conclusion of many evidence based reviews is that there is not sufficient evidence to confirm or refute the benefits of a specific clinical approach or therapy. Extensive research continues to help fill these gaps in our knowledge. The National Institutes of Dental and Craniofacial Research are putting extensive resources towards answering important clinical question through the Practice Based Research Network (PBRN) that was funded for 7 years with \$67 million dollars. You can join the network and help provide and be a part of advancing oral health care for the future. Divaris Named Class of 1958 Distinguished Service Award Recipient



Kimon Divaris (2011) was named this year's recipient of the Class of 1958 Distinguished Service Award. The award is the highest honor granted to research conducted under the sponsorship of the School of Dentistry and recognizes research conducted by the faculty of the School of Dentistry that has "the greatest potential for direct contributions to the practice of dentistry and dental health generally." His paper titled "Surface-Specific Efficacy of Fluoride Varnish in Caries Prevention in the Primary Dentition: Results of a Community Randomized Clinical Trial", sought to determine the extent to which fluoride varnish had differing effects according to primary tooth anatomy and baseline tooth pathology (caries or developmental defects of the enamel). Its findings add to the accumulating body of evidence demonstrating the efficacy of fluoride varnish in preventing caries in primary dentition. Study co-authors were Gary Slade, John W. Stamm and John Preisser. Congratulations Kimon for this distinguished award and your hard work!

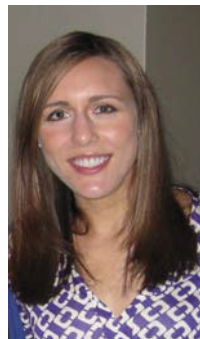

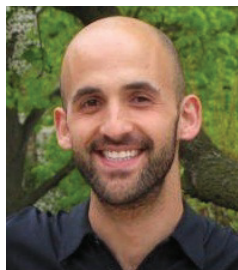
Department Welcomes New Residents

IN MEMORIAM

We recently lost one of our own. **Elliot R. Shulman (1980)** died this past February in Morgantown, WV. Local anesthetics (LA) are the safest and most effective drugs in medicine for the prevention and management of pain. However, the young child patient presents a challenge for the dentist in relation to the safety versus risk. Dr. Malamed will review current LA formulations, their efficacy and safety in children and discuss differences in a child’s anatomy and technique for achieving effective safe pain control. Current research into new drugs (e.g. phentolamine mesylate buffered LAs, articaine) and techniques (e.g. intranasal LA mist for maxillary anesthesia, computer-controlled local anesthetic delivery) will be reviewed.

Medical emergencies can, and do, occur in the practice of dentistry. Dr. Malamed will review basic preparation of the dental office and staff, including specifics for the pediatric patient, to recognize and effectively manage these emergencies that might arise in both adults and children. Specific emergencies common to children will be reviewed, including bronchospasm (asthma), seizures, and drug over dose (e.g. local anesthetics, sedatives).

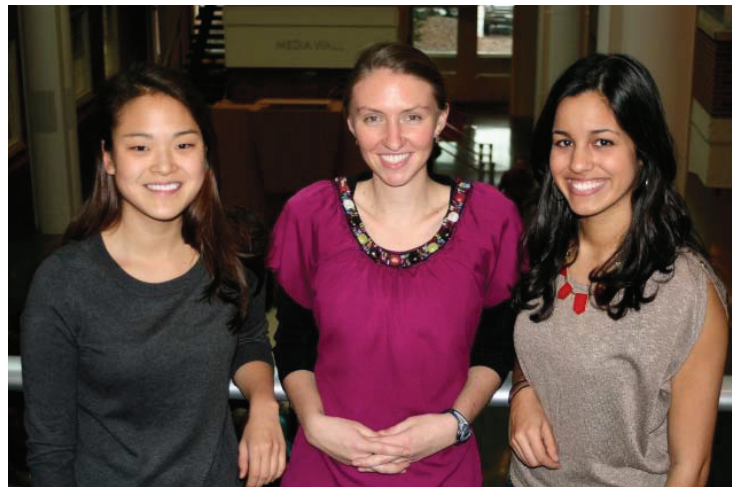
Excellence in Pediatric Dentistry Lecture Series 2013
